- 1.The acknowledgement shall be subject to the provisions of the Water (Prevention & Control of Pollution) Act,1974, the Air (Prevention & Control of Pollution) Act, 1981 and the Environment (Protection) Act, 1986.
- 2.This acknowledgement will not be used as an evidence for ascertaining the land title and its use.
- 3.The acknowledgement is from the point of view of control of pollution, and does not absolve the unit from making compliance of the other statutory obligations, prescribed under any other law or instrument, for the time being in force and the directions passed by the Hon'ble Courts.
- 4.The State Board shall have the right to conduct random checks or call information from the unit and make a formal consent order prescribing conditions etc., as required.
- 5.The Industry falls under **Green Category - Polythene & plastic processed products manufacturing (virgin plastics)** as per Head Office Order No. F.14(23) Policy/RPCB/Plg./153-189 dated 02/06/2020.

Specific Condition :

- 1 That this Acknowledgement is granted on the basis of documents uploaded online by the applicant/ project proponent. If any submitted document is found wrong on verification then this consent shall be revoked immediately
- 2 That this acknowledgement is being issued for manufacturing of Air Bubble Sheet roll of capacity 63 MT/Month and 2 DG sets of capacity of 163 KVA and 25 KVA respectively.
- 3 That ground water shall not be abstracted without prior approval of Central Ground Water Authority. Beside no trade effluent shall be generated by the unit.
- 4 That this acknowledgement of consent application shall cease to be valid in case of any change in product/process/operation/raw material/ capacity/ area or in information/ document submitted/uploaded at the time of seeking consent.
- 5 The applicant/industry/process/project shall have to comply with the provisions of Water (Prevention & Control of Pollution) Act'1974, Air (Prevention & Control of Pollution) Act'1981 & Environment (Protection) Act'1986 & the standards prescribed there under along with the general guidelines and/or directions issued by the Central Pollution Control Board or the Rajasthan State Pollution Control Board time to time.
- 6 This acknowledgment shall not be valid for installation/ operation of any boiler/ thermic fluid heater etc.
- 7 Unit shall not use any fuel other than cleaner fuels in the premises.
- 8 That the industry shall not operate any plant/process or does not carry out any activity which attracts environment clearance under provision of the EIA notification dt. 14.09.2006
- 9 That burning of non-hazardous waste shall not be practiced inside or outside the industry premises.
- 10 That the unit shall undertake regular cleaning and wetting of roads for control of fugitive dust emissions.
- 11 That the unit shall provide green belt in 33% of the plot area using concept of the social forestry and will develop green belt outside project premises in adjacent areas wherever adequate land is not available within the industrial premises.
- 12 That only cleaner fuel such as PNG, CNG or LPG will be used as a fuel in Boilers, Thermic Fluid Heaters, Furnaces and other utilities.
- 13 That the unit shall not involve in washing of plastics within their premises.
- 14 That the unit shall follow the guidelines of Plastic Waste Management Rules 2016.

This acknowledgement is in accordance with the directions issued by the Central Pollution Control Board vide letter no. B - 29014/1/90/PCI - I/17793 dated 21-10-1992.
